FACULTY

CHRISTOPHER HYER, DPM - CHAIRMAN

Dr. Hyer is a fellowship trained foot and ankle surgeon and partner at the Orthopedic Foot and Ankle Center. This is a unique foot and ankle specialty practice comprised of fellowship-trained MD, DO and DPM foot and ankle surgeons and where Dr. Hyer is Co-director of the Advanced Foot and Ankle Reconstruction Fellowship. Dr. Hyer is the Resident Director of the Grant Medical Center Podiatric Surgical Residency Program. Dr. Hyer is a very active regional, national and international speaker on foot and ankle reconstruction, orthobiologics and bone marrow aspirate, foot and ankle trauma, total ankle replacement and charcot foot salvage. Dr. Hyer is a dedicated researcher with over 125 peer-reviewed published articles in addition to multiple textbook chapters, technique papers and co-editor of the Primary and Revision Total Ankle Textbook.

DOUGLAS BLACKLIDGE, DPM

Dr. Blacklidge graduated as Salutatorian from Scholl College of Podiatric Medicine and was awarded the outstanding graduating student of podiatric surgery. He completed his podiatric surgical residency at Hutzel Hospital and the Detroit Medical Center Hospitals. This included participation in the Diabetic

Foot Clinic with the multispecialty Diabetes Center at Wayne State University's Health Center. Dr. Blacklidge completed a Trauma and Reconstructive Surgery fellowship with an AO Research Hospital in Mainz, Germany. He has also completed additional training for advanced techniques in peripheral nerve surgery. Dr. Blacklidge practices with a multispecialty medical group practice in Indiana. He has lectured and published on a variety of podiatric surgery topics and has helped advance podiatric surgical techniques such as joint fusions, internal fixation and peripheral nerve procedures.

JAMES COTTOM, DPM

Dr. Cottom graduated Magna Cum Laude from Scholl College and completed his residency in reconstructive and trauma surgery of the foot and ankle at the Detroit Medical Center. Dr. Cottom is extensively trained in the conservative and surgical treatment of diabetic conditions affecting the lower extremity including limb salvage. In 2005, he completed an AO International Trauma and Reconstructive Foot and Leg Fellowship under the direction of Sigvard Hansen, MD in Seattle, WA. Dr. Cottom also completed a Fellowship in Kurgan, Russia focusing on the Ilizarov technique for correction of acute trauma and complex deformities of the lower extremity in both adult and pediatric patients. He serves as the Fellowship Director of the Florida Orthopedic Foot & Ankle Center in Sarasota, FL.

WILLIAM DECARBO, DPM

Dr. DeCarbo completed a three-year podiatric surgical residency at Grant Medical Center where he served as chief resident. He completed a twelve-month orthopedic foot and ankle fellowship at the Orthopedic Foot and Ankle Center in Columbus, Ohio. He completed a six-week traveling fellowship both nationally and internationally learning advanced techniques in foot and ankle surgery. Dr. DeCarbo is active in research in the field of foot and ankle surgery and his research is published in peer-reviewed professional journals. He also is a review editor for the Journal of Foot & Ankle Surgery and Foot & Ankle Specialist.

MICHAEL DUJELA, DPM
